On Wednesday, February 18, 2009, the Banning Police Department and the Allied Riverside Narcotic Enforcement Team obtained search warrants for 1526 N. Florida and 1542 N. High Street, in the City of Banning in reference to a shooting investigation that occurred on Wednesday, February 11, 2009, in the 1600 Block of N. Durward.

Officers searched the location for suspects, additional firearms and the gun used in the shooting. During the warrant execution at 1526 N. Florida, officers apprehended a juvenile suspect and his co-conspirator, Heidi Irene Fox.

Two additional suspects, Ryan Anthony Meeks and Sandra Michelle Pleasant were arrested as accessories after the fact and booked into the Riverside County Sheriff's, Smith Correctional Facility in Banning. The juvenile male was booked into the Riverside County Juvenile Hall for 664/187 PC, Attempt Murder, 245 (a) (2) PC, Assault with a Deadly Weapon/Firearm.

Heidi Irene Fox was additionally charged with 664/187 PC, Attempt Murder, 245 (a) (2) PC, Assault with a Deadly Weapon/Firearm, with a bail of \$1,000,000. Ryan A. Meeks and Sandra Michelle Pleasant were charged with 32 PC, Accessory, with a bail of \$50,000. All suspects remain in custody.
